- Al-Rasheed City Project (Al-Rasheed Camp formerly) at the Governorate of Baghdad: this project includes the construction of a modern city of an approximately seventy thousand housing unit with integrated services, the project's infrastructure shall include sport, medical, commercial, and entertainment centers.
